1	The funds must be utilized strictly for the purpose they have been released.
2	An amount of Rs. 1500/- (50% of approved funds) for SMDC/SMC Trainings is released/authorized in favour of each approved Govt. MS/PS District Kathua and An amount of Rs. 750/- (50% of approved funds) for Community Mobilization is released/authorized in favour of each approved Govt. MS/PS of District Kathua.
3	The funds shall be utilized after observing all codal formalities/norms and no deviation of funds whatsoever is allowed.
4	No liability be created over and above the approved budget.
5	The expenditure be booked under "Centre Share and State Share @ 90:10 ratio" under revenue component of Samagra Shiksha for the year 2023-24 seperately.
6	A separate cashbook shall be maintained for said expenditure and shall be maintained for inspection of audit teams/officers from Directorate of Samagra Shiksha.
7	All the Vouchers/bills/receipts shall be preserved in original after being duly attested by the Head of the Institution.
8	The concerned DDOs shall submit the utilization certificate to this office before the culmination of current financial year.
