Subject:- Compliance report regarding Teaching by Head of Institutions and Lecturers of School Education Department to the 9th and 10th standard students.

Reference:- This Office vide Circular No. CEOK/25846 Dated:- 15-09-2023 & Reminder issued vide No CEOK/30415-67 Dated: 30-10-2023.

In reference to the subject and reference cited above, instructions were passed on to all the Principals (Cluster Heads) of this District regarding Teaching by Principal/Lecturers and Headmasters of HSS/HS of the cluster to the 9th and 10th standard students of schools (HSS/HS) in the cluster.

However, during recent inspections by the undersigned/ higher officials during B2V5 programme the directions have not been adhered by some of the institutions bringing a case of non-compliance of the directions of higher authorities.

Whereas, the HOIs were time and again instructed to rope up their teaching faculty for making up the deficiency of teaching staff in their schools but situation is totally different as observed by the undersigned during the field visits. It has also been observed that many of the institutions have not submitted the detailed time table (including the HOI) as per instructions conveyed through above referred circular.

As such, a final call advising all such delinquent HOIs is issued through this Notice for compliance of instructions thereof. No further opportunity shall be given and case of non-compliance by the HOIs shall be forwarded to the higher authorities for strict Disciplinary action against them.


