Sanction is hereby accorded to the release of funds to the tune of ₹. 27027600 (Rupees Two Crore 70 Lakh Twenty Seven Thousand six hundred Only) in favour of following Zonal Education Officers of District Kathua approved under AWP&B 2023-24 through SNA mode on account of free uniform under RTE Entitlement (Elementary) for class 1<sup>st</sup> to 8<sup>th</sup> students enrolled in Government Schools. The funds are released as per the breakup given hereunder, to disburse the funds to the Aadhar based accounts of the eligible students or the parents (in case the bank account of the student is not available) @ ₹. 600/- per eligible student through DBT (Direct Benefit Transfer) mode.

1. The zonal Education Officer will transfer the funds to the beneficiaries within 7 days before 30<sup>th</sup> June 2023.
2. The funds shall be utilized for the purpose it is released.
3. The funds released @ ₹.600/- per eligible student.



4. The parents of the students may be advised to purchase the uniform by adhering to the norms and specifications to be notified in the Government Order to ensure uniformity and quality. (Annexure Included).
5. Zonal Level Committees be framed headed by Zonal Education Officer to monitor the DBT.
6. The accounts and other record be kept open for audit and inspection.
7. All the eligible students shall be covered and detailed 18 column report be furnished before 10<sup>th</sup> July 2023.
