1. The funds shall be utilized strictly for the purpose for which the funds have been released under the Centrally Sponsored Scheme of Vocationization of Secondary & Higher Secondary Education.

2. Deviation of funds from one subject of expenditure to another is not allowed under any circumstances.

3. The funds shall be utilized after observing all the codal formalities and following GFR-2017 rules

4. An amount of Rs. 16,000 per school is released /authorized in favour of Govt High Schools approved under Vocational Education upto AWP&B of 2018-19 @ Rs. 1000/-per Guest Lecture per class per trade where vocational Education is being taught in both classes 9th & 10th.

5. An amount of Rs. 32,000 per school is released /authorized in favour of Govt Higher Secondary Schools approved under Vocational Education upto AWP&B of 2018-19 @ Rs. 1000/-per Guest Lecture per class per trade where vocational Education is being taught in all the classes 9th to 12th.

4. An amount of Rs. 8000 & Rs. 16,000 per school is released /authorized in favour of Govt High & Higher Secondary Schools respectively approved under Vocational Education in the AWP&B of 2019-20 to 2021-22 @ Rs. 1000/-per Guest Lecture per class per trade where two trades approved by the Ministry of Education, GOI, and vocational Education is introduced this year and will be taught in class 9th in High School & in classes 9th & 11th only in Higher Secondary Schools in current Academic session.

4. An amount of Rs. 4000 & Rs. 8,000 per school is released /authorized in favour of Govt High & Higher Secondary Schools respectively approved under Vocational Education in the AWP&B of 2019-20 to 2021-22 @ Rs. 1000/-per Guest Lecture per class per trade where only one trade approved by the Ministry of Education, GOI, and vocational Education is introduced this year and will be taught in class 9th in High School & in classes 9th & 11th only in Higher Secondary Schools in current Academic session.
